Greetings Friends!

Often when we speak with the community one of the first questions that we are asked is "how many kids do you serve?" While that is a very important question as it gets to the degree to which we are designed to meet the community need, the question we hear less but work tirelessly to answer is "with what level of quality do you serve the children and families in your programs?"

As I reflect on this question anchored in continuous pursuit of improved quality, I look back over the past few months and I am proud to report to you, our community and backbone, that we have endeavored to elevate quality in both physical plants and staff competency.

To address our staff competency, our program leaders have engaged all social service staff in Family Services Credential training. While all of our staff are educated, this training is tailored uniquely to prepare our mission partners to provide services which are well informed with our program foundations and operational philosophies that directly support fidelity implementation of our mission, vision, values and key metrics for success. This fall, our education staff will receive the same training at somewhat less depth but to ensure alignment of understanding across the agency.

In looking around at physical plants, our Facilities Director and team does not strive to benchmark against our peers or other similar programs, but rather to provide the highest possible quality that allows our staff to fully and safely implement our services. To that end, this summer, in partnership with **PNC Bank**, the **Edwardsville Junior Service League** and the **Office of Head Start** we have installed a new playground at our Edwardsville center, we have power washed and provided detail safety inspections and repairs at all playgrounds, replaced failing shade structures with high quality and permanent fixtures, continued our efforts to purchase our Alton Essic Robinson site to ensure that we can continue to provide services to this community for many years to come. All child attendance centers received a deep cleaning with repairs to paint, flooring and fixtures as needed such that we would all be proud to have our own children or grandchildren attend any of our facilities.

So, the next time you speak to one of our employees, feel free to ask about our services and then dig a little deeper and ask how we provide the highest quality child and family support services in Madison County. Needless to say, I'm sure you will be impressed!

New Pavilions Installed at Three Head Start Locations

As we are all aware, summers in the Midwest can be brutally hot. That's why this summer, we installed new pavilions at three of our Head Start locations. The work began in May and was completed in June. The locations include: Collinsville, Granite City South, and Granite City North. We were able to purchase them at the end of the previous fiscal year with remaining funds from our annual budget.

The three locations were selected to receive a new pavilion because they had storm damage to their current pavilion, or in the case of Granite City North, they didn't have one at all.

Once the new school year begins, the new pavilions will offer much-needed shade to our staff and students. They can also be utilized as an outdoor classroom. While the agency purchased two of the pavilions, we're happy to report that **Tindall Construction Inc**. donated the pavilion to Granite City North. **Scot Garman** of Tindall Construction also constructed them for us at all three locations.

We're thankful for those who worked hard to make this happen and we look forward to our teachers and students being able to use the pavilions for many years to come!



Meet Your Policy Council: Jessica Lewey



Head Start parent **Jessica Lewey** knows a lot about the program, and is a great resource for other parents who might have questions or concerns. Lewey is involved with our Board of Directors. She is also actively involved in our Policy Council.

"I like being on both because I learn information about what's going on before a lot of others know about it."

Lewey has been a Head Start parent for the past 16 years. She has five children, all of them have been involved in the program. Currently, she has a child in the Early Head Start home-based program, and another child who's attending Head Start at Bethalto. That's the location closest to her home in Cottage Hills. Even though it's in the area, she still relies on the transportation provided through the program.

"I have no transportation, so if my kids have to go to the eye doctor or dentist, Head Start will provide transportation," says Lewey. "As a single mom of five, that really helps me out."

She admits that when she first became involved in Policy Council, she was shy about speaking up. But as the years have gone by, she's more comfortable and confident and has really come into her own.

"And now, I'm my kid's voice, I answer questions, I give my opinion when needed," she says. "I also want to be helpful to other parents. If someone won't speak up, I don't mind speaking up."

Lewey has benefitted from donated items in the program. She sees firsthand how the program is helping out in the community.

"I also like how Riverbend Head Start will help moms out if their kids need clothes, diapers, wipes, and things like that."

It's because of the help that she's received that she likes to pay it forward, and regularly donates to help other Head Start families in need.

Lewey first learned about the Head Start program 16+ years ago while applying for the WIC (Women, Infants & Children) program. And now, she regularly encourages other families to consider Head Start. It's another full circle moment for her and she loves spreading the word about her time here.

"You guys, I would say are like my second family," she says.


For now, she's busy getting ready for a new school year. It will be quite the contrast from the start of the 2023-24 school year. A year ago, she says her daughter Ariyah would cry and become upset during those first days at Bethalto. But that quickly changed.

"I would say the first week of her going to school her behavior changed," says Lewey. "She was coming home talking about what she did at school. They were doing butterflies in the classroom and they let them go. And to this day, she still talks about that."

School Bus Donation

A decision by a neighboring program in Ohio to cease providing transportation services prompted them to donate a pair of school buses to the agency.

Both buses are 20-passenger vehicles equipped with seat belts. They are a 2020 and a 2019 model, respectively.

Head Start's Regional Office was aware of our recent efforts to start up transportation, made the connection and paved the way for us to add these two buses to our fleet.

Both buses are in excellent shape and have less than 10,000 miles. They are a very welcome addition to our fleet, as we have two aging diesel engine buses that we are looking at retiring as costs to maintain and repair them exceed their value.

With mileage under 10,000 miles, these donated buses are nearly new! This is a huge cost savings for the agency, as a new bus today will cost around \$110K.

We are grateful for the care that the **Hancock Hardin Wyandot Putnam Community Action Commission** took with these buses. We also appreciate the support from the office staff with the **Office of Head Start Region V** for quickly making the connection and enabling us to acquire these buses.



RHSFS employees including **Chuck Hancock, Beverly Bock** and **Victoria Bock** drove to Findley, Ohio on Thursday, May 30th to retrieve the bus donation. The drive averaged about 9 hours each way!

Delta Dental Community Grants Reception

In November 2023, the agency was awarded a grant in the amount of \$20,000 to assist with our efforts to provide dental screenings and treatment for our Head Start students.

Following the grant award, members of our health team were invited to attend Delta Dental's annual community grants reception.

It was held on April 25,2024 in Naperville, IL. Health Specialist **Casey Cope** and Health Advocate **Michelle Baalman** attended this year's reception.

"Each organization got to speak for a couple of minutes about what we do and how we're planning on using the funds," said Cope. "The Delta Dental grant is crucial to our program to help pay for the extensive cost of dental work on the kids and dental education for our families."

Cope has attended the reception for the past couple of years, but it was Baalman's first time attending.

"It was a great opportunity to learn from other recipients of resources that we can possibly utilize in the future," said Baalman. "I look forward to attending the Delta Dental reception again next year."

In her role, Baalman organizes the dental clinics for the centers twice a year with Miles of Smiles.

"This past year, Granite City South (GCS) started placing Miles of Smiles consent forms inside all of our enrollment packets – so that we were able to pull all children needing dental exams from class," says Baalman. "This worked out great and GCS had a total of 92% of center-based children with dental exams by the end of April."



Accounting Specialist **Tobbi Tyson** celebrated her one-year anniversary with the agency on April 3rd, and she's already making a lasting impact with her colleagues.

"Having just celebrated her first year with the Agency, Tobbi has been a very valuable addition to our finance team," says President/CEO **Gene Howell**. "Tobbi has been very dependable, accurate in her work, and demonstrates a quiet and steady confidence."

"Tobbi is my sounding board when I need someone else with an understanding of the accounting principles and regulations that impact the work of our department," says Finance Director **Tim Warren**.
